FDP: Our Foreign and Security Program continued our series of workshops on security policy with the German Federal Academy for Security Policy. These events featured high-level German and U.S. decision-makers and address the strategic challenges to the transatlantic community. An area of special focus is China policy, raising our profile on issues such as German relations with China, the impact of Germany's decisions on its 5G network, and German policy on investment screening. An AICGS Senior Fellow has been leading a consortium of scholars working on cyber and energy security in the context of hybrid warfare ? their proposal for a three-year project has been approved by NATO and they are working with governments and industry partners to secure funding for their research on this growing concern for transatlantic security.

DAAD/AICGS FELLOWSHIP: In 2019, the DAAD program accepted 6 fellows out of 19 applications. Each fellow undertook a project that concluded with a presentation and written product. The fellows interacted with AICGS staff as well as each other to encourage collaboration. AICGS also released two DAAD Alumni Newsletters covering 2001-2019. A Fellowship Alumni Breakfast was held in Berlin in May 2019, to wrap-up the year and discuss accomplishments.

GENERAL PROGRAMS/OTHER: In 2019, AICGS received grants from several donors and foundations. Allianz sponsored a speakers series focusing on Economic issues, as well as Carl Siebel and AT&T, who sponsored an exchange program. The German Embassy provided funds related to a book project dedicated to Guido Goldman, and the German Marshall Fund provides general support for Institute Activities. The ERP Exchange program conducted activities in the Fall of 2019, related to educating US and German participants on cultural and economic issues. With the generous support of a Deutschlandjahr grant from the German government, the Society Culture and Politics Program hosted a series of four talks from October-December 2019 surrounding the 30th anniversary of the fall of the Berlin Wall. This is also an opportunity to reflect on three decades of development in an issue area. Topics covered include women's rights in unified Germany, memory of the wall and reunification, and East-West differences.

ERP NEXT GENERATION: In 2019, the ERP Next Generation program continued on year 3 of a 3 year grant. There were 12 participants in 2019. Two-day seminars and programs took place in Washington in Spring and Fall 2019. Briefings in Germany took place in the June 2019. The Geoeconomics cohort participated in a virtual conference in January 2019. The Society, Culture and Politics group participated in a conference in February 2019. Further two-day conferences on economics and trade happened in Washington DC in April 2019. A final two-day briefing on the project took place in June 2019, followed by the publication of a final policy report.
